SCF Pickleball Management Systems



SCF Pickleball now powered by CourtReserve

In 2021, the SCF Pickleball Club board approved the replacement of our club's fragmented, obsolete technologies with a single, integrated software-as-a-service platform called CourtReserve. The CourtReserve system went live at SCF on 1 June 2021 and now supports the club's member roster, email communications, court reservations, ball machine (+ court) reservations, and event registrations. A ladders module was promised but is still not available.

The CourtReserve system may be accessed from your computer using a web browser or from your smart phone using a mobile app. The mobile app may be downloaded for free from the Google or Apple stores. Some of our members prefer using the mobile while others prefer the web browser. Many members use both platforms – the computer when they are home and the mobile app when they are on the go.

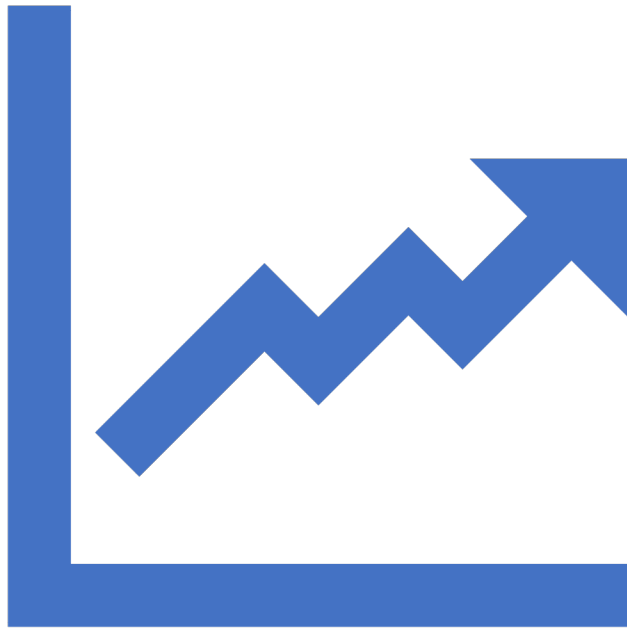
The SCF HOA granted permission for the SCF Pickleball Club to accept electronic payments (credit card or e-Check) for new and renewed annual dues. All payments are now made online through CourtReserve and the club no longer accepts cash or checks. This has simplified the workload for the club treasurer and enabled the club to transition membership dues from a fixed calendar year cycle to a rolling anniversary cycle.

CourtReserve intends to offer a new League Platform (ladders) function in Jan 2023. CourtReserve is planning to develop a Ratings module and Tournament Management module later in 2023.

CourtReserve's original fees began at \$170 per month or \$2040 per year.

CourtReserve modified their fee structure in June 2022 increasing the club's costs to \$242 per month or \$2904 per year.

Activating CourtReserve's League Platform (ladders) will add \$25 to the monthly fees. The club's new CourtReserve costs will be \$267 per month or \$3204 per year.

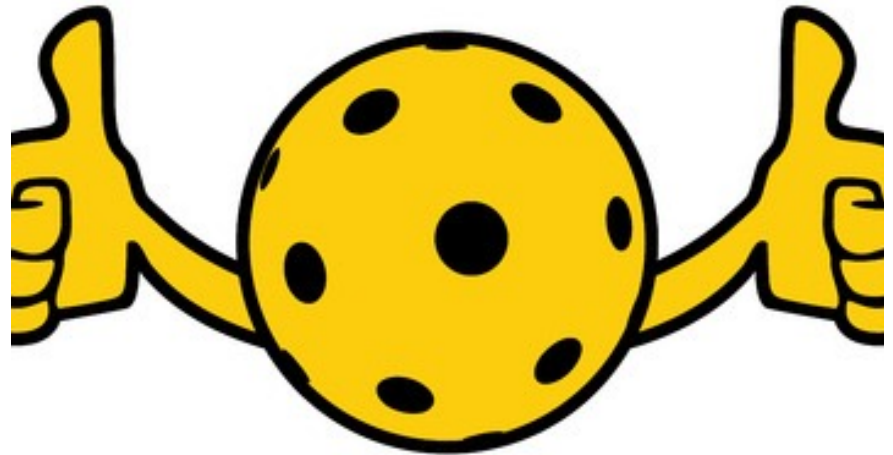

Balancing the Evolving Demand

The club offers multiple styles of play to satisfy our diverse membership. Some members prefer to participate in club sponsored events where the players, courts and matchups are organized for them. Others prefer to make a court reservation and organize a private group to play together. Others prefer the open play format where they can just show up at the courts at any time and join a game.

Events are defined as rotations, ladders, skills & drills, clinics or any other club sponsored activity.

Many of our members participate in multiple styles of play while others focus on a single style. If you ask a member that does not participate in events how much court time should be allocated to organized events they might say “**zero**”. If you ask a member that only participates in events how much court time should be allocated to organized events they might say “**all of it**”. The club is perpetually seeking the optimum balance between open, private and organized play.

Note: Open Play was suspended during Covid-19 but was restored by the SCF Pickleball Club Board on June 7, 2021 and has been available to members for the past 18 months.

Balancing the Evolving Demand

The SCF Pickleball Club Board created a special committee in Q1 2022 to review the club's current system for assessing player skill levels and make recommendations based on their findings. Step one in the committee's evaluation process was to survey the membership. Several of the survey questions sought feedback on member preferences for their style(s) of play.

As expected, many players participate in more than one style of play. The most popular option is organized play (club events such as rotations or ladders), followed by private play (reservations) and trailed by open play. Members have also enjoyed instructional offerings such as skills & drills or modules.

Building the Calendar of Events

Multiple factors influence the development of event calendars including seasonal fluctuations in residents and ambient temperatures, skill level populations, the number of available courts, lighting conditions, finding volunteer event coordinators, and accommodating other styles of play.

- Summer days have low demand due to many members being away from SCF and winter days have high demand due to members returning to SCF.
- High summer temperatures typically restrict play to early and late in the day and these times must be shared with other styles of play. The moderate winter temperatures allow play during all daylight hour so the various styles of play can be more easily accommodated.
- Events held at the Wagner can be assigned up to 16 courts while events held at the Sage are limited to 8 courts. Skill levels with the highest member populations (2.5, 3.0, 3.5) typically require more courts per event than skill levels with lower populations (2.0/Beginner, 4.0+).
- Lighting at the Wagner is better than Sage.

Event Formats and Eligibility

The calendar of events for the 2022-23 winter season offers events every day of the week. Each day offers a set of 3 to 5 events using different formats and eligibility criteria.

Formats

- Rotations
- Ladders
- Skills & Drills
- Clinics
- Tournaments

Eligibility Criteria

- Skill Level
- Gender

- **Rotations** are intended to be social events where the games are timed and frequently end without a team reaching 11 points. They are mostly restricted to one or two levels where players are mixed randomly. A few rotations allow many skill levels and are loosely segregated so that inexperienced players are not matched against highly skilled players. Rotations may have additional eligibility restrictions such as gender or age.
- **Ladders** are competitive events where the results are tracked, and court assignments are based on a player's past success. Ladders are restricted to skill levels 2.5 and higher.
- **Skill & Drills** are instructional sessions where players learn, develop and/or refine their pickleball skills and strategies. These sessions are typically structured with appropriate drills and strategies for the target skill level.
- **Intro to Pickleball** is a single session clinic that teaches basic rules, court positioning, and ball striking to SCF residents that are interested in trying pickleball.

2022-2023 Winter Season

Club events (except for Skills & Drills) have been reduced from 120 minutes to 90 minutes in length. Multiple evening sessions are now offered from 5-6:30p. The Tuesday and Thursday 2.5-4.0 Ladders are suspended but will resume after CourtReserve deploys the League Platform (ladders) functionality.

2022-2023 Winter Season

This chart shows a typical format for a 120-minute event versus an option for a 90-minute event. The bottom line is that a 90-minute event can work but the warmup time needs to be planned into the event because courts will not be available prior to the event. It is also important that players move on and off the courts quickly during the transition between events.

The 120-minute format provides one 10-minute warmup, six 12-minute games, and 3 minutes between games to change courts. Most of the games reach 11 points before the 12-minute whistle. **The event typically has 20 minutes of unused time after game six.**

The 90-minute option provides one 6-minute warmup, six 11-minute games, and 3 minutes between games to change courts. **Players will have 6 minutes less total play time compared to the 120-minute format.**

Chronology of Board Decisions

The chart below illustrates how the baseline court allocations (excluding club events) have changed since 6/1/21 when CourtReserve went live. The current allocation of court hours is 52% open play and 48% reservation. The next slide displays the adjusted allocation with club events.

Pickleball Players League

The Arizona Pickleball Players League (APPL) is a statewide team-based pickleball league. It currently operates in the following regions:

- Southern Region (Tucson and surrounding southern Arizona area)
- Casa Grande Region (communities in the Casa Grande and surrounding area)
- East Valley Region (cities in the eastern Phoenix metro and surrounding area)
- West Valley Region (cities in the western Phoenix Metro and surrounding area)
- White Mountain Region – Summer League Only (Show Low, Pinetop, Lakeside and surrounding area)

The league has been in existence since 2012 and originally started out as the East Valley Interclub League (EVIL). The Arizona Pickleball Players League became incorporated as a nonprofit corporation in 2019.

In 2022, 3900 players participated on over 300 teams in APPL leagues throughout Arizona.

Background

- The SCF PB Club bylaws permit intercommunity play at no cost on a reciprocal basis. APPL has been deemed intercommunity play, so the SCF Pickleball Board is allowing home matches to be hosted on the SCF Wagner courts from 3-5pm for any APPL team with a majority of players from the SCF Pickleball Club.
- The 13-week season begins in January 2023 with round robin play in Jan-Mar and the playoffs in April.
- There are currently eight (8) APPL teams in the West Valley Region that have registered with SCF as their home court location.

General Guidelines

Policy / Guideline

Members who are self rated are responsible for the accuracy of their rating. Members can change their rating every 3 months. Review the skill level requirements prior to making a change to ensure you meet the criteria of that skill level.

Skill level requirements can be found at on the club's website at <https://www.scfpickleballclub.com/skill-ratings-info.html>

The court reservation policy states that if after 10 minutes, you are not on the court, the court is open for other players to use.

If you reserve a court and no longer need your reservation, be courteous and cancel your reservation as far in advance as possible so that other members can make use of that spot.

If you register for an event and can no longer make it, be courteous and cancel your registration as far in advance as possible so other members can move up from the waitlist. A member with multiple no-shows may be removed from future events.

Court Reservations

Policy / Guideline	Rationale
<p>Courts are available for booking on a 7-day rolling window. Day 7 will open at 7:15p AZ time.</p> <p>Example: If today is Monday, you will be able to reserve courts at 7:15p today for the following Monday</p>	<p>The 7-day rolling window was chosen because it is easy to remember. Having a consistent time of day is our priority. If you are not at home and have a smart phone, you can reserve courts at 7pm using the mobile app.</p>
<p>Courts may be reserved for a total of 120 minutes per day per member. The minimum reservation duration is 60 minutes, and the maximum is 120 minutes. The default duration is 120 minutes but may be changed prior to clicking "Save".</p> <p>Exception: The system will permit a member to reserve additional court time for a <u>same day reservation</u> that is made <u>less than 60 minutes prior to the start time</u>.</p>	<p>Discourage members from reserving large blocks of court time and thus spread the court utilization across a larger population of members but allow members to reserve additional court time if it is available that same day.</p>

Court Reservations

Policy / Guideline	Rationale
A new court reservation may not create 30-minute gaps prior to or following the proposed reservation.	Maximize court utilization by preventing new reservations from creating 30-minute gaps prior to or following the new reservation. 60-minute gaps are permitted because 60 minutes have been deemed sufficient play time for a stand-alone reservation.

Ball Machine + Court Reservations

Policy / Guideline	Rationale
Ball Machine + Court may be reserved on the Wagner Courts between the hours of 6-9pm. The ball machine can only be reserved for 1 hour and this 60-minute reservation counts against the daily 120 minutes of court time allotted per member.	The battery charge time on the ball machine lasts approximately 3 hours. The 6-9pm window was chosen because it allows the machines to fully charge during the day and have that charge last over the combined machine reservation periods. Additionally, reservation courts are only available at Wagner between 6-10pm.

Event Registrations

Policy / Guideline	Rationale
<p>Events are available for registration on a 7-day rolling window. Day 7 will open at 7:15p AZ time.</p> <p>Example: If today is Monday, you will be able to register at 7:15p today for an event that is being held on the following Monday.</p>	<p>Refer to the rationale for Court reservations. The 7-day rolling window and 7pm open time are identical for court reservations and event registrations.</p>
<p>A member may only participate in one event per day. However, a member may reserve court time and utilize open play on the same day he/she participates in an event.</p>	<p>Make club-sponsored events available to a larger population of members.</p>
<p>Events close for registration or withdrawals at 7pm the night before the event. If you need to withdraw from an event after 7pm, email the event coordinator to inform them. Event coordinator information is available in the event description.</p>	<p>Give the event coordinators a static window to prepare for their pending event. CourtReserve sends reminder emails to the registrants 24 hours before the start of the event so registrants have time to withdrawal before the 7pm close.</p>
